Commissioner Hart moved that the Landmarks Preservation Commission acknowledged that the property at 5436 S Puget Sound Ave, Piper Funeral Home, is of historic significance, however in consideration of discussion, it should not move forward for listing on the Tacoma Register of Historic Places. Lihuang Wung outlined the discussion, noting feelings of shock and surprise and the importance of outreach, education, and information-sharing. Norman Brickhouse added comments.

Noemi Cagatin-Porter outlined the discussion in her group, noting that discrimination is still occurring.

Mr. Smiraldo outline the discussion in his group, noting accumulative trauma for people of color, dealing with racism, and anger regarding the lack of changed, how complaints are made, and reconciliation and reparation for black community.

The special joint meeting recessed at 6:18 p.m., and reconvened at 6:25 p.m.

4. NOMINATIONS TO THE TACOMA REGISTER OF HISTORIC PLACES

A. College Park Historic District Recap of Commission review to date, information requests, schedule revisions

Mr. McKnight outlined the staff report as provided in the packet and facilitated a discussion regarding significance, boundaries, guidelines, data requests, future schedule, survey distribution, and next steps.

Commissioner Hart requested clarification on the goal of this discussion and expressed opposition of the nomination.

Vice-Chair Mortensen agreed with staff's summary regarding the significance and stated that she is comfortable continuing with the established boundaries proposed by the applicant.

Chair Bartoy proposed not moving forward with the guidelines at this point. Commissioner Johnson stated the guidelines may alleviate Commissioner Harts concerns and agreed that the discussion should be delayed. Commissioner Hilsendeger agreed with delaying the discussion on guidelines.

Commissioner Stewart and Chair Bartoy thanked staff for providing the data. Commissioner Johnson asked if there is data from the current banking industry and real estate industry relating to problems with home loans.

Mr. McKnight outlined the draft survey mailer that will be distributed to community members.

Discussion ensued regarding enlarging the QR code, adding a small map, removing the background as the building shown is not part of the location discussed, survey recipients, removing the term "historic properties", and adding a URL of the online survey.

Chair Bartoy proposed pushing the public hearing to a January meeting to allow ample time for staff and Commission discussion. Commissioner Johnson agreed. Mr. McKnight stated the February 9, 2022 meeting would be the earliest for the public hearing if setting of the hearing date occurred at the January 12, 2022 meeting. The Commission agreed on the longer timeline.

Vice-Chair Mortensen requested clarification on tabulating the public response data and asked about additional information on other districts and how significant support was defined.

Discussion ensued regarding North Slope District support, the response window for the survey, notice requirement in the Code, timeline of mailout.

AGENDA ITEM 4A: 602 North Ainsworth (North Slope Historic District)

BACKGROUND

Built in 1893, this is a contributing property in the North Slope Historic District. The applicant proposes to add a skylight to the roof that faces N 6th St. The skylight would be visible from the right of way. In addition, they propose a number of changes at the rear of the house, including adding a dormer with an egress door, windows, and a small balcony on the second floor. The roofing, siding, and railing of the new balcony will match the house's existing material. They also propose removing existing porch lattice and door to open up the existing basement entrance. Finally, on the southwest elevation, the applicant proposes adding two skylights to the existing roof as well as reducing the size of an exterior window. This façade faces the neighbor's house and is not visible from the right of way. The new window trim and siding will also match the house's existing materials.

BACKGROUND

On May 3, 2021, a resident of the "College Park" Neighborhood near the campus of the University of Puget Sound submitted a written request for consideration of the neighborhood as a historic special review district overlay zone. This would create a new Tacoma Register Historic District. It is south of the Proctor Business District and north of Sixth Avenue commercial corridor.

The district is nominated as an example of a cohesive neighborhood that reflects the broad patterns and history of Tacoma as well as for the distinctive characteristics of its structures, which embody early twentieth century architecture. DISCUSSION

The following elements of the proposal and related discussion are summarized below, followed by a summary of the draft public review document.

Nomination and District significance (reviewed on August 11 and October 13)


Based on the Commission's guidance, the nomination appears eligible under the criteria for designation to the Tacoma Register of Historic Places, although additional narrative context could be added to benefit the nomination.

Guidance from the Commission is that the district meets Criterion A as a cohesive and highly-intact neighborhood of dwellings that is significantly associated with and reflect Tacoma's early development period, and that represents the broad patterns of social and economic history of Tacoma. The nomination focuses on the themes of railroad era development and speculation, the streetcar system and period of rapid economic growth prior to 1940, and the World War II period. Under this criterion, the Commission has directed that other historical narratives or themes that also are relevant to the district should be included, including the practice of redlining. This can be included in a revised nomination.

The Commission's guidance is that it also appears to meet Criterion C as an area that embodies the distinctive characteristics of dwellings built in Tacoma from the late 19th to mid-20th century.

Proposed Boundaries (discussed August 25 and October 13)

Staff provided additional discussion on boundaries on October 13, noting that the boundaries are those already designated as a National Register Historic District and reflect a combination of factors, including development history, arterials, zoning boundaries, plats, and other factors, such as the presence of the university campus.



General regulatory framework and district requirements (guidelines, design review thresholds, exemptions) (discussed August 25, October 13 and December 8)

The general convention of historic district requirements are well established for the North Slope and Wedge Neighborhood Historic Districts, including:

- New construction and exterior work to contributing properties requiring a permit requires design review
- Work exempt from permits, interior work, alterations to noncontributing properties, and landscaping are exempt
- Additional considerations, such as relaxing requirements for alterations to secondary elevations and certain items like windows, has been proposed.

Additional feedback and direction was received at the meeting on December 8, 2021. This feedback included:

- There should be specific guidance in the guidelines for solar panel installation (current language in the North Slope/Wedge guidelines provides guidance on location and encourages the commission to consider technical requirements)
- There was a recommendation that all residential historic district guidelines should be reviewed going forward
- New guidelines should be less restrictive, focusing on ensuring that new construction is "in-keeping" with context, with less emphasis on specific styles or architectural elements
- Design review requirements should be limited to visible elevations
- Guidelines should be "pro-density" with a focus on preserving neighborhood character
- Additions that increase habitable space, especially for smaller homes, should not be discouraged

Public Review Document

Based upon Commission feedback, staff presents the following for consideration by the Commission, for public comment at a hearing tentatively scheduled for February 8, 2022.

- 1. College Park Historic District nomination to the Tacoma Register of Historic Places. This includes an amendment to address the history of "redlining" in Tacoma.
- 2. Draft ordinance language, including a map of the proposed district showing its boundaries as proposed. Please note that:
 - a. No changes to the boundaries as submitted are proposed at this time.
 - b. The draft language includes two alternatives in the "district exemptions" section that reflects feedback received form the Commission.
 - "Alternative A" proposes exemptions that are similar in scope to the North Slope and Wedge Neighborhood Historic Districts, and includes exemptions for alterations to non-contributing properties, interior work, work that does not require a permit, private landscaping, plumbing and utility work, and work within the street surface ("between curb faces").
 - "Alternative B" expands on the list of exemptions to include alterations that are not visible from the street, and exempts windows that are on secondary elevations from design review.
- 3. Draft design guidelines. These guidelines are based on the currently adopted guidelines for the North Slope and Wedge Neighborhood Historic Districts, with changes added to reflect input from the Landmarks Commission. The guidelines are included as a framework for public information, and would be formally reviewed and adopted following the establishment of the historic district, at which time additional amendments could be introduced and additional opportunities for public review and comment would occur.

The principal differences from the existing North Slope and Wedge Guidelines include:

- a. General Guidance
 - i. The first item includes language that encourages the Commission to consider the needs of residents and owners when applying the guidelines.
 - ii. The second item includes language encouraging the Commission to focus on the effects on the district as a whole when considering design applications.
 - iii. The last item encourages the Commission to emphasize sustainability, efficiency and comfort when reviewing proposals.
- b. Windows
 - i. Guidelines for windows emphasize primary elevations. Additional flexibility is encouraged for secondary elevations.
 - ii. Language on thermal retrofitting has been softened and makes recommendations regarding approaches to improving thermal performance, and includes language regarding storm sashes.
- c. Roofs
 - i. Additional flexibility has been included regarding roof additions and changes to roof height.
- d. Parking and Accessory Structures
 - i. Language prohibiting attached garages and carports has been softened for post-war structures.

Approval of the public review document; set public hearing date for February 9, 2022.






