







Tacoma's Current Emissions (2019)





- Update Code to encourage small-scale urban agriculture and food making businesses
- Develop a climate change-ready urban landscape and habitat strategy
- Complete City's network of sidewalks, bike connections, curb ramps, and SRTS
- Coordinate on transit projects and planning, and support the green transportation hierarchy
- Update City street design policies and practices
- Improve land use density bonuses and tax credits

CAP ACTIONS & LAND USE





- Update zoning and development standards to promote sustainable new development
- Support zero emission technology innovation in marine, rail, trucking
- Assess flooding impacts on critical roads, infrastructure, steep slopes
- Implement the Affordable Housing Action Strategy
- Collaborate on building retrofits
- Improve commercial energy codes

- CAP ACTIONS & LAND USE
- Reduce construction & demolition waste stream
- Increase cross-jurisdictional policy coordination and climate adaptation collaboration
- Incorporate green and equity elements into land development RFP/RFBs
- Improve green jobs tax credit
- Review zoning and development standards for industrial lands
- Complete a green economy study
