Narrative:	On 09/02/2020 starting at 0700 hours I was logged in as O028, working in an official off-duty capacity at Tacoma Pacific Fred Meyer, 7250 Pacific Ave. I was wearing my TPD issued uniform and utilizing my TPD Patrol vehicle. I retained all rights and responsibilities of an on-duty Tacoma Police Officer.
------------	---

Right at 0700 hours, multiple callers reported hearing shots fired in the vicinity of 40th & S D St. I remained at Fred Meyer for my off-duty post at that time. After officers arrived, a few moments later Sgt. Mires called out on the air "SHOTS FIRED." At that time I responded to assist.

Upon my arrival approximately 1-2 minutes later I took up a tactical position with Sgt. Mires. His vehicle was positioned on the NE corner facing NW. Sgt. Mires was standing at the open drivers door. I observed an empty Glock magazine at his feet. Other officers were working on taking a suspect in custody, who was laying down next to a gray Ford Focus station wagon on the NW corner of the intersection. I remained with Sgt. Mires as other officers cleared the associated residence and tended to the suspect. I noted bullet holes in Sgt. Mires' windshield and asked him if he was OK. He said "I'm ok. Scared, but OK." I did not ask Sgt. Mires about what happened.

Once the scene was secured, two witnesses identified themselves to me. I identified these two as W/JACKSON and W/LAVALLIE. They stated the live in a tent near the area. They told me about the first shooting that prompted TPD response. They observed an older black pickup truck, low to the ground, with a white canopy, driven by a heavy set white female. There was also a black male passenger. The witnesses heard shots being fired but did not see who was firing the shots. The truck fled at a high rate of speed after the shots. After police arrived, they observed the black male in the gray Ford Focus get out of the car and start shooting at officers. They observed officers return fire, saying "it was completely justified what they did, he shot at them first." I had W/JACKSON and W/LAVALLIE remain on scene until detectives could respond for an interview.

I then secured the outer scene perimeter with crime scene tape. I noted several shell casings behind Sgt. Mires' vehicle, and created an inner perimeter with crime scene tape around his car. I remained on scene with the witnesses until relieved by Lakewood PD Investigators shortly before 0900.

Narrative:	<p>On 09/02/20 at approximately 0706 hours while on uniform patrol I responded to 3856 S D St in reference to a shot fired call.</p> <p>Upon arriving from the north I observed several officers making entry into a house. I also observed PPS WEAVER outside with a male on the ground in handcuffs. I was advised by SGT. KELLY to assist PPS WEAVER. I ran over to him and identified the male on the ground was shot in the chest and we were not going to be able to move him. At the same time TFD Medic 1 was arriving on scene. PPS WEAVER and I decided a medical gurney would help us move the male. I went over and got the gurney from TFD and advised them to standby I would bring back the male to them. PPO SPLANGER and I loaded the male on to the gurney while PPS WEAVER and SGT KELLY provided cover for us (it was unknown at this time if a suspect/shooter was still in the house we were in front of). PPO SPANGER and I ran the gurney with the male on it to TFD Medic 1 and gave the male to TFD personnel.</p> <p>I then went back to my patrol car, I was told to stay with the male in Medic 1 and follow them to the hospital. I stood by with the male at Tacoma General in the ER. I was advised by the Doctor the male was in stable condition, I passed this information along to SGT KELLY. I was relieved by Lakewood PD Officer. Nothing further.</p>

Narrative: I, M.BENBOE (X-249) am currently assigned as a 4 Sector Community Liaison Officer (CLO) in the city of Tacoma. On 09/02/2020 at approximately 0700 hours I heard via my in car radio officers get dispatched to the report of shots fired in the area of S 38th St and S "D" St. There were multiple callers

calling in reporting the same. As officers began to arrive, the address was updated to 3856 S "D" St. A short time later I heard officers advising "Shots Fired".

At this time, which was approximately 0707 hours I responded to the above mentioned address priority from the Tacoma Police Head Quarters. While en route officers updated the suspect was down and had been hit. Officers on scene were able to safely detain the suspect.

Upon my arrival, I assisted officers B. TERWILLIGER (F-168), S. OVENS (F-051), T. SNYDER (F-193), and SGT. KIM (S-177) in entering the listed residence and conducting a security sweep. During our search of the residence, later identified (O) PHILLIPS, SHARON and (O) FONTANA, ROSANNA were both found uninjured in separate bedrooms on the second floor. No other persons were located inside the residence.

Upon my initial contact with (O) PHILLIPS, I observed she was laying in the fetal position on a bed in the center of the bedroom. (O) PHILLIPS is an elderly woman who appeared confused upon contact. She was able to verbally provide her name, and advise she was not injured, though she had urinated in her nightgown. (O) PHILLIPS did not provide any information to me pertaining to the incident.

(O) FONTANA was located in a separate room. She too appeared confused, and to possibly under the influence of an unknown substance, or suffer from some type of mental illness.

Tacoma Fire entered and assisted officers in getting both (O) PHILLIPS and (O) FONTANA down stairs and outside to the front yard where they were both examined further by TFD. Given both (O) PHILLIPS and (O) FONTANA'S mental states, they were transported as a precautionary measure to St. Joseph Medical Center for further evaluation.

CLO BUTTS (X-228) and I were assigned by SGT. KELLY (S-271) to follow the ambulance to the hospital and remain with both (O) PHILLIPS and (O) FONTANA until relieved by detectives.

(O) PHILLIPS and (O) FONTANA were separated at the hospital with (O) PHILLIPS being placed outside room "D" and (O) FONTANA being placed inside room "D". They remained separated until contacted by Detectives BYERLEY and SCOTT from Boney Lake PD. Neither (O) PHILLIPS or (O) FONTANA made any statements to me regarding the incident.

At approximately 1008 hours, Detectives BYERLEY and SCOTT advised CLO BUTTS and I could clear the hospital.

SGT. KELLY (S-271) was updated prior to our departure from the hospital.

This concluded my involvement with the incident.

On 09/02/20 at 0707 hours I (PPO SPANGLER) responded to 3856 South D St reference a shooting.

Units initially responded to a report of 6 shots being fired and after units arrived they advised they too had been shot at. The suspect had also been shot.

I arrived on scene and parked to the north of the location on South D St. I approached the residence on foot and took up a position of cover on the sidewalk in front of the residence just to the north. The suspect was lying on the ground just inside the open door of vehicle which was parked in front of the residence. The residence was currently being cleared by other units. I moved to the suspect to assist in getting him out of the area and to medical aid. I crouched down next to the suspect. I looked into the vehicle and observed a black handgun between the driver's seat and the door frame. Without prompting he began speaking to me. The suspect told me he was shot and asked for help, I assured him help was on the way. The suspect then began repeating "I'm sorry" and "I shouldn't have done that." An ambulance arrived and another unit got their gurney from them. The gurney was wheeled over to the suspect and I lifted his upper body off the ground and onto the gurney. We then wheeled him over to the waiting ambulance.

Once the scene was secure I began canvassing the area. I spoke with the originals RPs, W/KLEVJER, KYLE and W/KLEVJER, JAMIE, at 3845 South D St. They said they heard yelling coming from 3856 and looked outside; W/KLEVJER, JAMIE was looking out the front storm door and W/KLEVJER, KYLE out a front window. They saw a black female and black male at the front door of the residence knocking on the door and saying "hello" repeatedly. At one point one of the individuals was using a hose to hit against the side of the house to get someone's attention. The suspect exited the residence with a gun in his hand. The other two ran towards a car, a black pickup, which was parked on D St across the street from 3856 as the suspect began shooting at them. W/KLEVJER, KYLE and W/KLEVJER, JAMIE said they heard 2 volleys of 3 shots, for a total of 6. The black pickup sped off southbound and then possibly turned west at the intersection of South 40th St / South D St. The suspect went back into the residence. A short time later the suspect again exited the house, went to the car parked in front of the residence and appeared to get something from the vehicle. He went back towards the northside of the residence where there was a side door. The suspect was standing on the northside near a refrigerator which was sitting on the lawn when 2 patrol vehicles

approached going south on S D St. When the male saw the patrol vehicle he entered the residence through the northside side door. W/KLEVJER, KYLE and W/KLEVJER, JAMIE thought the male was inside for maybe 1 to 2 minutes before he exited again. He walked into the front lawn and began shooting at the police, they then heard multiple shots being fired. W/KLEVJER, KYLE and W/KLEVJER, JAMIE described the male exactly as I had seen him, a black male approximately 40 years old wearing a grey Russell Wilson jersey.

At W/KLEVJER, KYLE and W/KLEVJER, JAMIE'S residence were O/MCMILLAN, O/NOLAN, and O/CHAPPO. They had all arrived after the shooting and were only there to carpool to work with W/KLEVJER, KYLE.

In front of 3844 South D St I observed WA AWS9396 parked facing south. The rear windshield appeared to have been shot as the there was a small brake at the bottom of the windshield.

I was then flagged down by the residents of 3842 South D St, O/SMITH, MELANIE and O/SMITH, HEATH. O/SMITH, MELANIE and O/SMITH, HEATH said their residence had been struck by multiple bullets. O/SMITH, MELANIE showed me damage above a window to the left of the front door if facing, it was too high for me to see exactly what had caused the damage. Also to the left of the front door was a bullet hole and two more to the right of the front door. Inside the residence one of the bullets had come through and was lying in the living room. I advised O/SMITH, MELANIE and O/SMITH, HEATH not to touch anything.

O/SMITH, MELANIE and O/SMITH, HEATH said they had been asleep when they heard three "pops" which they thought might have been fireworks. As they lay in bed they heard multiple more pops which they then knew were gunshots. O/SMITH, MELANIE and O/SMITH, HEATH said they then heard a male voice saying he had been shot and asking for help.

I informed on scene detective of everything I had discovered and been told.

I stayed on scene as security until I was informed I could go.

Narrative:	<p>On 09/02/2020 at approximately 0707hrs Officers in the south end of the city responded to the area of 40th and S D St for the report of shots fired. Officers arrived in the area and within minutes the report of shots fired. I responded from the north of the city and arrived approximately 2 minutes later. The scene was still an active incident with officers surrounding the residence located at 3856 S D ST. I approached from the north and met up with Officer BASS who was taking a position of cover north of the residence behind a brick wall. He informed me that officers were inside the residence clearing the interior, the shooter was down outside the residence and no report of officers hit by gunfire. I observed to the south of me Officers WEAVER and FORBES near a vehicle parked directly in front of the residence. A male was lying on his side with his head facing north and feet south facing toward the open door of the vehicle parked out front. I called for Tacoma Fire Department to enter the scene to the south where they would have cover from officers, vehicles and buildings and to provide a medical rig. I directed two officers to go to the medical rig and obtain a gurney. Officer MEFFEN responded to the rig, obtained a gurney with myself providing cover for him and we made our way to the downed person. With assistance from officer WEAVER and MEFFEN the individual was loaded onto the gurney and transported over to TFD. PPO MEFFEN stayed with the individual until relieved by LAKEWOOD Detectives. The wounded individual was in the custody of medical staff and LE within 3-4 minutes of my arrival.</p> <p>Once the individual was secured I re-positioned myself as an officer of cover from outside the residence until officers inside the residence had it secured. Two females were contacted inside the residence and brought out to awaiting officers and they were soon transported to St Joseph Hospital for either medical or mental trauma from the ordeal. Once the scene was secure I took a roll of scene commander and assigned officers to various duties. Sgt BRANDON MIRES, PPS SLY WEAVER and PPO BRET TERWILLIGER were identified as using their assigned service weapons to stop the threat of the active shooter. SGT MIRES was assigned to on scene SGT BRIAN GARRISON, PPS SLY WEAVER assigned to PPO BASS and PPO TERWILLIGER to PPO OVENS. All officer involved vehicles were left on scene and they were transported to TPD HQ with their assigned officers. I directed PPOS BUTTS and BENBOE to the two females that were located inside the residence to stay in direct contact with them at St JOSEPH HOSPITAL until relieved. PPS ROBILLARD was assigned to an earlier victim of the shooting that had driven himself to the Hospital prior to officers arrival at the incident scene. The individual at the scene and later determined shooter was transported to Tacoma General Hospital and PPO LUKE WALLIN was assigned until relieved by detectives.</p> <p>Due to the large scene at 40th and S D ST. I directed officers on scene to commence with taping off a center perimeter around the house, a secondary perimeter around patrol vehicles outside the inner perimeter and an overall outer perimeter clear of the working scene. Security officers were then assigned at all compass points to insure no breach of the perimeter by onlookers. An entry point to the scene was established for all responding officers, detectives and support units at S 40th St and Fawcett. I remained on scene until briefed by investigating agency LAKEWOOD Detectives. I cleared the scene which concluded my involvement.</p>
