## Form of Government Presentation

At approximately 5:49 p.m., Sheila Gall, General Counsel, Association of Washington Cities (AWC), presented on form of government, including a brief history of AWC, basic information on services offered to the public and city governmental functions in other Washington cities, different city classifications and forms of government, separation of power between the different forms of city branches, characteristics, trends from other cities, and the pros and cons of the different forms of government.

Discussion ensued regarding AWC's available resources for Washington elected officials, a hybrid form of government, public utilities, prequalification criteria for city managers, policy versus administration, and the difference between a resolution and an ordinance.

# **City of Tacoma Government Structure**

At approximately 6:50 p.m., Martha Lantz, Deputy City Attorney, City Attorney's Office, presented on the City of Tacoma's government structure, including the current form of government; roles and responsibilities of the City Manager, Mayor, and City Council within the framework of current form of government; Tacoma Public Utilities; and the Civil Service Board.

Chair Wamback proposed that for the next meeting, the Committee would discuss and identify ideas on the different forms of government so when a speakers or panels attend, those ideas can be shared with them to solicit reactions, opinions, experiences, or expertise.

## **Communications Discussion**

At approximately 8:04 p.m., Reay reported on the results of the first Public Outreach Subcommittee meeting. The Subcommittee discussed and agreed on the text of the communication piece which the Committee can distribute in a variety of formats. The Subcommittee discussed the addition of a QR code, translation options, and advertisements for maximum public engagement and accessibility.

Chair Wamback then opened the floor to the Committee for location suggestions. The Committee requested City staff to provide possible location options by the next meeting on February 1, 2024.
