4. Viridian Grove Project Loan Terms Approval

Staff provided information and request approval of the loan terms and authorization for the Tacoma Community Redevelopment Authority (TCRA) Administrator to execute the loan documents and related security document with VBT Viridian Grove LLC for the Viridian Grove Project

MOTION: Azaria Azene moved to approve a total of Two Million dollars (\$2,000,000) of City of Tacoma Affordable Housing Funds to VBT Viridian Grove LLC with the following terms and authorize the TCRA Administrator to execute the loan and related security documents once finalized:

- 40-year deferred payment loan
- 4.5% interest (compounded annually)
- Affordability period of 40 hears will start on the date the project is placed in service
- Principal and accrued interest will be due in full to the TCRA at the end of the affordability period
