# **Briefing Items**

# **City Manager's Office**

- 6:03 Ted shared the CPAC recruitment season is coming up. The period will be August 27<sup>th</sup> to September 15<sup>th</sup>. There are 5 open seats of which four are at large seats and one youth seat. Applications are reviewed by the chair of CPAC then sent to the chair of Community Vitality and Safety Committee (CVS) who reviews applications and decides who to interview. Interviews with CVS occur November 14<sup>th</sup>. Terms start in the new year. Youth seat is September through June though can work for

- 6:09 Lt. Katz shared there are currently 5 Community Service Officers (CSO), budgeted and hoping to get up to 10. Currently 3 are in the field and have response to 167 calls, completed 136 police reports, and spent over 308 hours on calls. There is a full-time sergeant who oversees the role and a lieutenant who helps oversee the program. CSOs will only be dispatched by a sergeant.
- Reach out to Lt. Katz via email if you would like to participate in a ride along. The Community Policing Academy (formally Citizen's Academy) is coming up in September. There is a procedure for applying and Lt. Katz highly recommends it. It is 9 12 weeks.
- Esther asked about the time between when a qualifying 911 call comes in and when a CSO is dispatched. Lt. Katz will look into it and get back. Allen and John would welcome a CSO to attend a CPAC meeting to learn from them

#### **Police Reports Review**

- 6:24 Review of most recent batches of complaints starting with 23-0098 where an officer was laughing at the scene of a death which was not sustained. Louis and Adrienne both said it is common sense to not laugh at a scene of a death. Lt. Katz said there is a policy in P 1.1 which has courtesy and unbecoming performance information and shared the language associated with policies. Adrienne asked if the complaint was filed under courtesy instead of unbecoming conduct, if it would have been upheld and raised concerns about different perspectives. Tracy asked if there is a policy about body cameras being muted as they were on this scene. Lt. Katz shared there is a policy and language that body cameras don't need to be activated if officers are unlikely to interact with the public and can have them muted for personal or sensitive conversations. It is recommended that officers state why they are muting their camera before going on mute.
- 23-100 Complainant alleges that detective was abrasive however the conduct was deemed appropriate and within training given the circumstances. Lt. Katz confirmed it is within policy.
- 23-103 Officer told a person with a totaled car that she needs to renew her tabs. Committee members discussed that this is another example of an instance where empathy and understanding should be taken into consideration when interacting with community members who have experienced trauma instead of needing to dictate or control a space. Members also flagged bias in the writing of the report related to complainant not appearing dissatisfied as people, especially people of color, are taught not to react in front of police in order to stay alive.

- 23 0032 Committee members note that the Chief signed the letter in June 2023, but the
  letter was not sent to the complainant until February 2024, a full 10 months of wait time. Esther
  flagged that all three of the previous complainant letters were significantly delayed and it's
  unreasonable to expect community members to be satisfied with that performance. Esther
  shared it reflects poorly on TPD as community members do not know that the Chief signed off
  on it and the delay is with the City Manager. Jacques shared he doesn't know specifics around
  the timelines and will bring it up and put it in the memo which will be put together from today's
  meeting.
- 23-0069 There we no comments on this complaint.
- 23-0094 Allen asked if intent to offend needs to be proven. Lt. Katz said it is not an element
  listed in the policy for intent to be proven. Allen encouraged "I" language in reports for matters
  that are subjective. Members and Lt. Katz discussed context and that complaints come from
  people who have had negative experiences. Adrienne asked if there are any restorative
  practices in place. Lt. Katz said the limitations of the formal process is this process which is
  designed to find facts and make a determination. There is not a policy to support or require
  restorative conversations. Allen highlighted that there is no appeal process or even record of
  bureau-level investigations like transcripts of testimony. Lt. Katz shared that he is willing to bring
  conversations forward. Adrienne said the community needs more. Lt. Katz offered to help tease
  out the details of what that could look like and assist with bringing it to the chief.

# **Public Comment**

• 7:23 – Allen opened the floor for public comment. There was no public comment.

#### **Presentations and Discussions**

#### 21<sup>st</sup> Century Policing report discussion

- 7:25 Allen opened the floor for discussion on which recommendations CPAC would like to receive updates on.
- Louis asked why CPAC should limit to a few recommendations and would like to documentation and feedback on each recommendation as each should be tracked. John seconded.
- Allen would like to hear about use of force. Louis said he is most interested in 29, 30, 31, 36, 45, and stops and arrests column on page 86.
- Louis also proposed that instead of meeting in September that TPD provided a written explanation which CPAC can review and discuss. Allen liked that this would create a written document that can be shared with community. Esther asked if it could be broken into bite-sized pieces like a set of responses to recommendations 1 – 6 for example or utilizing the sections that are outlined in the report. No members expressed opposition to the idea.
- 7:33 Louis made a motion to ask TPD to respond in writing to each of the 21 CP recommendations with information about what has occurred with each recommendation. The motion passed. Committe members would also like status of implementation and any other relevant information included.
- John expressed interest in page 64 related to uses of force by officers and found eye-catching information related to certain officers with a high number of uses of form. John would like to know if the same officers are still high users of force.

- Adrienne would also like information on implementation status for example "50% implemented", "implemented and reviewed", and any additional details with progress reporting including where TPD is and where TPD would like to go.
- Allen noted page 86 has a strong recommendation. Allen would like to learn more about recommendations 8 and diversity, 13 and 14 around less lethal force, 15 related to excited delirium, would also like to see aggregated data, 30, 31, 32 and 34 related to stops and seizures, 38 beyond CSOs, 41 and 42 as CPAC has talked about scenario-based training, 48 related to training and teaching components, 49, 50 and 51 about officer wellness which is a CPAC priority from the retreat and all of page 119 133. However, Allen notes the committee has decided they would like to hear about every recommendation
