## **City Reports**

## **City Manager's Office**

• 6:09 – Mayor Woodards shared that she is working on getting an initial meeting set up with Local 6 and hopes to share a date at the next meeting. Louis asked if there will be draft resolution language for CPAC to review. Mayor Woodards shared that there will be something that says that the Council is committed to moving forward but it will be a on a quick timeline, perhaps Wednesday but would need it back by (likely) the next Wednesday to be included at the July 23<sup>rd</sup> Council Meeting. Mayor Woodards asked if there is specific language that should be included. Louis affirmed that a commitment to oversight from the council is important to include. John seconded.

## **Tacoma Police Department**

- 6:15 Michelle shared there will be a couple policy modifications that will be shared with the
  policy subcommittee in about two weeks. She said the policies will not be a heavy lift and are a
  result of the CALEA recommendations. The policies will be duty to intervene related to noncommissioned officers.
- 6:17 Ralette shared that the subcommittee is discussing subsection 1.8 related to the complaints section and the level of input for the 21 CP presentation. Michelle said she has someone working on 21 CP presentation but is in the heat of budget season so will have something in a few weeks.
- 6:19 Lt. Katz shared the community service officers are out on the street and were dispatched
  to a vehicle prowl earlier this morning. TPD is budgeted for 10 CSOs and by July 15 there will be
  5 on staff (including those in the 6 8 week training program). There are currently 3 in the field.
  Their role will likely evolve more but they have only been in service since last Tuesday, July 2.

## Early Intervention System - Tacoma Police Internal Affairs office

- 6:24 Lt. Katz gave a presentation about the Early Intervention System and answered questions from committee members. Ralette expressed interest in participating in a conversation about calibrated thresholds for EIS and Lt. Katz said he would be happy to participate or facilitate that conversation. asked that CPAC ask Mayor Woodards to include language that includes a calendar and
timeframe for bargaining and moving forward with oversight that reflects the importance of this
issue and contribute to transparency in the resolution. Sally shared this would be encouraging to
community members to see and would speak to the concerns a number of folks have shared as
well as strengthen confidence.

- 7:40 Allen proposed that CPAC postpone the review of reports and opened the floor for discussion about how to best approach complaints so the committee can review in a timely manner. Adrienne proposed a special meeting where complaints are the only topic as well as adding the complaints review to the top of the agenda before city staff reports and presentations. The committee also discussed reviewing complaints in a subcommittee. The chairs will discuss more next week.
- 7:45 CPAC voted to table complaints review to the next meeting.
