#### 5. Tidy Up Tacoma at 6:11

- Presented by Arly Hyatt, Asst Division Mgr, Environmental Svcs.
- Overview of current actions and new actions with additional funds from newly-assed excise tax.
  - i. Full-time litter and cleanup crews, proactive cleanup of litter and debris in public rights-of-way, trails, encampments, bill credit payment assistance, and new community partnerships
  - ii. Working on getting fully staffed and trained.
  - iii. Survey with chance to win \$100 gift card on website, as well as information for community members on how to get involved.
  - iv. Commissioner Ladenburg asks what training the work crews receive.
    - 1. Answer: Unknown but will find out.
  - v. Commissioner Ladenburg asks if work crews are still sourced from inmates.1. Answer: Not the majority, but some work crews still do.
  - vi. Commissioner Ellefson asks what is available for individual families with excess trash.
    - 1. Answer: City's Call-2-Haul program is available to any resident, twice per year.

# 6. Climate Action at 6:18

- Presented by Kristin Lynett, Sustainability Officer.
  - i. Overview of climate change impacts caused by heavy flooding, smoke from wildfires, excessive heat, higher emissions, and excessive waste.
  - ii. The City's climate impact plan includes cutting emissions via all-electric transportation and new buildings, educating the public, and planting 25,000 more trees.
  - iii. Biggest impact items for community members to take action: switch to electric vehicles, reduce meat and dairy intake, borrow, fix, share, and use up our resources, plant trees, and switch households to all-electric.
  - iv. Commissioner Lugo-Gonzalez asks what largest impediments are to reaching the goal of planting 25,000 trees.
    - 1. Answer: not enough land on public property for planting.
  - v. Secretary Walton asks if it is more harmful to the environment to purchase a new car and discard the old one for sake of switching to an electric vehicle.
    - 1. Answer: Most of the climate impact comes from driving the vehicle; not its production or disposal.
