



Figure 1: Metro Parks Tacoma Planning Matrix





Top Priorities for Investment for Programs Based on the Priority Investment Rating




Top Priorities for Investment for Facilities/Amenities Based on the Priority Investment Rating



Park Access

60% say the parks their household uses the most are not within a 10-minute walk of their home.



Park Access

48% use the facilities/amenities multiple times a week.

1% of respondents say they never use the facilities/amenities

Park Access

98% say the most important action to enhance the future of Metro Parks Tacoma over the next 5 to 10 years is to ensure natural areas within the city are maintained for future generations.

Note: Park service in Tacoma is provided by the City and by Metro Parks Tacoma. 3,900 acres of passive open space are primarily managed by the City

This strategic direction contemplates the comparative ratios of programming offered per mission area, the total cost of ownership of the infrastructure and the operation that supports programs and services, facilitative programming, and partnerships.

- Approaches to facilitative programming.
- Balancing investment in community identified high priority programs and services with investment in more niche or targeted programs.

Place. Parks and Public Recreation Spaces as "Third Space" of Choice

This strategic direction contemplates 10-minute walk coverage, youth mobility, youth outdoor and physical activity, level of service, and amenity and program availability by mission area.

- Edit Neighborhood Park classification to allow more flexibility of amenities and activities.
- Focus on route improvements.
- Create local ambassadors/community advocates/friends of park spaces.


Level of Service

BACKGROUND

Bills Adopted by State Legislative Session Necessitating Proposed Code Changes

- Substitute Senate Bill 5290
 - Mandates **new level of service** for Land Use permits
 - Provides exceptions to days counting towards level of service
 - Imposes financial penalties for exceeding level of service
 - Goes into effect January 1, 2025
- Substitute House Bill 1105
 - Requires **public notice** to include *start* and end date of comment period
 - Goes into effect on June 6, 2024 staff has already updated our templates.





PUBLIC COMMENT (JUNE 5 PUBLIC HEARING)

1 Commenter:

- More responsibility should be put on developers in submitting good documents for review and adhering to timelines.
- Non-responsiveness or delays on the applicant's part of over 30 days should result in 60 days of additional time to permitting review.

DRAFT CODE — LEVEL OF SERVICE

Changes to TMC Chapter 13.05 – Land Use Permits and Procedures

- New levels of service:
 - Permits with no public notice, final decision in 65 days
 - Permits with public notice, final decision in 100 days
 - Permits with hearing, final decision in 170 days
 - Includes exceptions
- Modify purpose of pre-application to facilitate better applications
- Include new payment deadline date/s

**Proposed Changes/Additions - New levels of service:

Exceptions to include – days between notice of public meeting and public meeting





DRAFT CODE — PUBLIC NOTICE

Changes to TMC Chapter 13.05 – Land Use Permits and Procedures

- Include start date for public comment on all public notices
- Goes into effect on June 6, 2024
- City in process of updating public comment notice now
