He mentioned work the City is already undertaking to address equity as it relates to housing needs, such as Home in Tacoma and MFTE. Expressed a need to understand where core transit lines will be and pair affordable housing development with those lines.

Wesley Rhodes mentioned his work on ETOD with the Picture Pac Ave Subarea Plan and expressed interest in learning more about the work N/N is doing around ETOD.

Vice Chair Karnes offered that we should think about transit as providing connections and access for people in areas with less opportunity to areas of more opportunities.

Tom Brennan wanted to make sure the Taskforce felt prepared to provide comments via the Miro Board to be distributed after the meeting.

Carrie Wilhelme ended the meeting with some housekeeping verifying the next steps for the Taskforce to provide feedback and utilize the Miro Board.
