REVISIONS TO THE SPECIAL PROVISIONS:

Revision #1

Delete special provisions section 2-02.1 and replace with the following Section 2-02.1:

2-02.1 Description

Section 2-02.1 is supplemented with the following:

(*****)

The Contractor shall remove the Impact Attenuator at the intersection of the 705 to Stadium Way Ramp and 705 to Schuster Parkway Ramp (as shown on the plans) as part of the lump sum item "Removal of Structures and Obstructions":

The Contractor shall remove the concrete curb as shown on Sheet 9 of the plans, near the intersection of Stadium Way and on/off ramp to/from SR 705, as part of the lump sum item "Removal of Structures and Obstructions".

Revision #2

Delete special provisions section 5-05.5 and replace with the following Section 5-05.5:

5-05.5 Payment

This section is revised to read:

Payment will be made in accordance with Section 1-04.1.

"Cement Conc. Pavement, ____-Inch Section", per square yard.

The unit Contract price per square yard for "Cement Conc. Pavement, ____-Inch Section" shall be full payment for all costs incurred to carry out the requirements of Section 5-05 and the Plans, and shall include furnishing and installing epoxy coated dowel bars and tie bars except as specified for "Epoxy-Coated Tie Bar with Drill Hole" in this section.

Tie bars that are drilled into existing cement concrete pavement that is not constructed under the Contract will be paid for under the item "Epoxy-Coated Tie Bar with Drill Hole" when included in the Proposal.

The cost to install the "Concrete Curb" depicted on Sheet 9 of the plans, shall be incidental to, and included in, the cost of work to install the "Cement Conc. Pavement, ____-Inch Section"

Revision #3

Add the following new section to special provisions section **5-05.3 Construction Requirements:**

(*****) Concrete Curb

"Concrete Curb" shall adhere to the requirements of Section 8-04 Curbs, Gutters, and Spillways and shall meet the requirements for Extruded Curb, Type 6.

Revision #4

Add the following new section to special provisions section 8-04.5 Payment:

This section is amended as follows:

As shown on Sheet 9 of the Plans, "Replace Concrete Curb", is incidental to the bid item "Cement Conc. Pavement – 12 inch Section"
