1. Question: In reference to the minimum requirements where the investment advisory firm must have Errors & Omissions insurance coverage of at least \$10 million would the City consider a firm with a lower amount?

For perspective, certain advisory firms may carry higher levels of insurance if they provide multiple asset-class services, such as equities, to retirement or custody assets and scopes carry much higher risk.
