The onsite walk through is expected to conclude by 10:00 a.m.

The time for questions and requests for clarification of the specifications has been extended and may be submitted in writing by 3:00 p.m., Pacific Time, Thursday, May 30, 2024, to Brandon Snow, Purchasing Division via email to bsnow@cityoftacoma.org. No further questions will be accepted after this date and time. The City will not be responsible for unsuccessful submittal of questions.
3. The posting date for written answers to all questions submitted will be posted on the Purchasing website at www.TacomaPurchasing.org on or about Tuesday, June 4, 2024. The City reserves the discretion to group similar questions to provide a single answer or not to respond when the requested information is confidential.

1. Remove the Submittal Checklist as a proposal form in its entirety.
2. Delete the existing Certification of Compliance with Wage Payment Statutes and replace it with the attached, revised Certification of Compliance with Wage Payment Statutes marked as Addendum No. 2.
