The unit Contract price per each for “Remove and Salvage Existing Sign” shall be full payment for all materials, labor, and equipment necessary to remove signs, salvage, and any material disposal.

The unit Contract price per each for “Furnish & Install Honorary Street Sign on Sign Post” shall be full payment for all materials, labor, and equipment necessary to fabricate and install side-mounted signs on an existing or new sign post as part of a larger sign assembly.

The unit Contract price per each for “Furnish Honorary Street Sign for Signal Post” shall be full payment for all materials necessary to fabricate signs.

The unit Contract price per each for “Furnish & Install Street Name Sign on Sign Post” shall be full payment for all materials, labor, and equipment necessary to fabricate and install side-mounted signs on an existing or new sign post as part of a larger sign assembly.

The unit Contract price per each for “Furnish & Install STOP Sign” shall be full payment for all materials, labor, and equipment necessary to fabricate and install signs.

The unit Contract price per each for “Furnish & Install 30 MPH Speed Limit Sign” shall be full payment for all materials, labor, and equipment necessary to fabricate and install signs.

The unit Contract price per each for “Furnish & Install Dead End Sign” shall be full payment for all materials, labor, and equipment necessary to fabricate and install signs.
