Deconstruction and Salvage- Discussion

Chair Walker was present to discuss the Deconstruction Resolution passed last night. The resolution passed to conduct a study. She explained the benefits around historic Tacoma with huge economic benefits and green jobs. Staff (Christina Caan) mentioned Salvage and Deconstruction are not the same but work hand and hand with one another. Staff and Chair Walker discussed with commissioners that the resolution is addressing:

- 1. Formalizing salvaging assessments
- 2. Incentivizing deconstruction projects and material use
- 3. Deconstruction of City-owned buildings
- 4. Workforce development on Deconstruction
- 5. City assistance with storage for salvaged and deconstructed materials

Staff are directed to report on each item by May 21st for better cost estimates, to incorporate in the budget process

Commissioner Brewer asked who the clients will be giving/selling deconstruction material to

Commissioner Hewett mentioned the issue with cost and storing them until use could be a problem

Chari Walker spoke on a part of the report are to find storage options, and she is open to suggestions on space, or other aspects around cost around deconstruction.

Commissioner Chang mentioned planning Building Capital with end for useful life for city building. He would like to see addressed what type of vehicles and area that the site will be located in, in terms of equity, health, and wellness.

Commissioner Hewett mentioned architects are discussing how companies started incorporating design for deconstruction

Chair Walker spoke about how after May, there will be some decisions being made
