Several points come to mind when it comes to the Charter Recommendations:

- 1) No to extended term limits. Just more time to get nothing done. Just look at our most pressing issues they have been prevalent since 2014 (DEI, Homelessness and such (I can refer to a Resolution where former Mayor Strickland instructed City Manager Pauli to work on those problems; 10 years ago!). We are being taxed on various levels, more Commissions being created and after all those years where exactly are we? Now I would be very hesitant to believe that those people in charge would be able to accomplish much by merely being on the job longer.
- 2) Anyone who has a lot of authority in decision making, should be voted into office by us, the people and we should be given background on anyone running for office and not just accept a statement that they write themselves (see the job performance of our City Manager she got to write that herself.!) All statements should be checked, but according the SOS, even our voters pamphlet are not fact checked. you could claim you're the 2nd coming, and SOS would print that in the voters pamphlet. That's actually a slap in the face and does not promote any kind of trust that we are getting the truth. It should also be more out in the open and publicized that anyone can check at the PDC ( Public Disclosure Commission) on campaign contributions and political affiliation.

Dear Mayor Woodards and Councilmembers,

We write today regarding the proposed amendments to the city's Charter, many of which cause us great concern. The purpose of a municipal charter is to simply lay out the basic structure of our government – similar to the US Constitution. And like the Constitution, it is difficult to amend for a reason. Policy must be left to our elected representatives in the legislative process. That process allows for robust public comment and lengthy consideration of the details of a policy prior to any vote. Because the charter is only amended about once a decade, if at all, it is critical that amendments be narrow in scope, clear a very high bar and not be used to achieve policy goals. Several of the proposed amendments seek to dictate policy for the city via our Charter. We believe this is the wrong approach.

Further, many of the proposals would be very expensive but charter review does not include analysis of the fiscal impact. In contrast, the legislative process includes a rigorous consideration of the fiscal impact of proposals. That is critical for two reasons: (1) we are in a budget deficit and (2) our revenue comes from taxes that most Tacoma residents believe are already too high. The legislative process equips the Council with the ability to consider and weigh competing resource needs across the city when voting on policy direction. For this reason alone, most of the charter amendments should be rejected and handled through the legislative process.

Finally, ordinances (unlike the Charter) can be amended or even repealed soon after passage if it becomes clear that there were unintended consequences or that the policy was simply wrongheaded. As noted, Charter provisions are not easily amended.

Some argue that the Charter review is an "opportunity to fight and win democratic protections needed in our community." Presumably, these unelected individuals view the Charter as a vehicle to affect policy in a way that would bypass the current legislative process. This would not only render our current city government superfluous, it would be fiscally reckless. For reasons outlined above, policy considerations should be handled through the legislative process. Indeed, if the Charter Review Committee believes they need six months to consider proposed amendments, how is the typical busy voter supposed to be able to thoughtfully consider the proposals they put forward in the amount of time voters take to complete their ballot?

For the reasons above, we believe that Council should not send to the ballot any of the proposed amendments that can be addressed in the legislative process. We would like to highlight the following proposed amendments that we consider to be the most troubling:

<u>Section 2.25 - Charter Review.</u> This provision makes clear that the Charter Review Committee views itself as a "super legislative body". They have approached their task as if it is their opportunity to make fundamental policy changes to the City. This viewpoint is incorrect and dangerous.

While we recognize and appreciate the enormous time and effort devoted by those on the Committee, the Charter Review should not be a process by which unelected individuals bring their policy wishes to the city. It is supposed to be limited to addressing the structure of government. We must keep that process limited and keep policy where it belongs - with our elected representatives on the City Council. For these reasons, we oppose expanding the amount of time for the Charter review process.

<u>Section 2.35 - Term Limits</u>. This amendment would double the length of time that one could serve on Council from 10 years to 20. Incumbents already have a significant advantage when running for office. Reviewing past elections, change in Tacoma's elected leaders only happens when a council seat is vacated either voluntarily or because of a term limit. Incumbency is a fat thumb on the scale in our elections. Significantly expanding the length of time someone can serve would further exacerbate this problem and would deprive the city of fresh viewpoints and new leadership.

We do think, however, that it is important to fix the problem created by the 10-year limit when a Council person chooses to run for Mayor. We believe strongly that seats on the Council should be filled by an election rather than appointment, whenever possible. The 10-year combined limit far too often causes the need for Council to appoint someone to fill a seat vacated by a mayoral candidate.

**TBC's Suggestion:** Change this proposed amendment to limit any person from serving more than two 4-year terms as council members and two 4-year terms as mayor. This would fix the current problem with the 10-year term without allowing one individual to stay on council for up to 20 consecutive years.

New Section 2.XX - Council - Full Time. This amendment would require that members serve full-time, among other things. Seattle is currently the only large city in our state with a full-time council. Tacoma has nowhere near the population or budget of Seattle. If Spokane, Bellevue, and Vancouver can thrive with a part time council, why can't Tacoma? The proposal for full-time council (and myriad staff) is too expensive. A full-time council is likely to result in the Committee on Compensation recommending a substantial salary increase. We believe we are better served with a part time council as councilmembers with other jobs bring 'real world' experience to government, promote public service by discouraging 'career politicians' and cost less. We prefer these taxpayer dollars be spent on public safety and public works-two issues that the community repeatedly cites as its top priority.

**TBC's Suggestion**: Reject this amendment entirely. If Spokane, Bellevue, and Vancouver can thrive with a part time council, so can Tacoma. We believe these taxpayer dollars will be better spent on public safety and public works, both of which need significant additional investment.

**New Section 2.XX - Policing Accountability.** This is a solution seeking a problem. There currently exist multiple layers of accountability in policing including:

• <u>Internal Affairs</u>, which vigorously investigates and reviews instances of alleged police misconduct to protect the public and our police force from such misconduct.

- The <u>Deadly Force Review Board</u>, made up of 6 voting members including two citizen representatives, which reviews TPD's investigation of incidents and makes its own determination whether the use of deadly force was within department policy. The Board reports its findings directly to the Chief.
- The <u>Pierce County Force Investigation Team</u>, which also exists to review the use of force. While
  Tacoma is part of the PCFT, it is prohibited from participating in the review of any incident
  involving our department. As such this provides a means for an independent review. Community
  members play a role on PCFI in checking for conflicts of interest.
- The <u>Community Police Advisory Committee</u>, made up of 11 community members none of whom are police, which conducts its own review of completed internal affairs investigations and advises the City Council, the City Manager and the Chief of Police on police policy and procedures, among other things.
- The <u>Commission on Accreditation for Law Enforcement Agencies (CALEA)</u> which is an accreditation agency to which TPD submits to maintain its accreditation. CALEA is the gold standard of professional excellence for public safety agencies. In order to maintain accreditation, TPD must undergo many reviews including self-evaluation, an annual Compliance Service Manager review and an onsite assessment done by CALEA every four years to demonstrate TPD are meeting the high standards of CALEA.
- <u>Civilian Chief of Staff.</u> TPD also recently added a civilian to their top executive team, Michelle Woodrow, who is the Chief of Staff. Having a civilian in the top echelons of the department brings an inherent layer of civilian perspective to all of the department's operations.
- <u>Body Cameras and Dash Cameras</u>. TPD employs the use of both Body Cameras and Dash Cameras collecting video which is publicly available for review.
- <u>The Judicial System</u>. And, of course, the police department is accountable for criminal activity through our court system.

This Charter amendment appears to be an attempt to create a parallel organization of unelected activists with no expertise in policing to oversee TPD. This would not only be prohibitively expensive it would run afoul of the current collective bargaining agreement and probably the law. Further, it would exacerbate the hiring problems at TPD as many at TPD would view it as another attack on them. This is the Seattle model – anyone paying attention knows that it's not working for Seattle given their serious problems retaining and hiring police officers.

**TBC's Suggestion**: Reject this amendment entirely. Neither put it on the ballot nor implement any of these recommendations by ordinance. While "police accountability" is a popular catchphrase, there already exist multiple layers of accountability for TPD. We believe this proposal would create an *unaffordable* bureaucracy, would impede recruiting at TPD and, if part of our Charter, would tie the hands of the city to make necessary changes in a timely manner.

<u>Proposed new section 3.XX Climate Commission.</u> While there is no question that the city can, should and does implement measures meant to help us do our part on climate, Tacoma has neither the expertise nor the budget to have our own "climate commission." We have federal and state agencies in charge of these issues. Those agencies are staffed with scientists and have the budgets needed to address these complex and highly technical issues. Furthermore, "climate" is not a regional issue.

**TBC's Suggestion:** Reject this amendment entirely. This is an attempt to create an expensive layer of bureaucracy that is neither necessary nor feasible.

Amendment 24 - Form of Government. This proposal does not promote a more representative, transparent, or effective form of government. To the contrary, this proposal would eliminate Tacoma's uniquely representative and democratic form of government where every resident has a majority of the Council representing them and the legislative branch directing all policy and budget priorities of Tacoma. This proposal dilutes legislative accountability and creates a new executive bureaucracy with veto power, creating a form of government with greater administrative power and less transparency. This proposal is being driven, at least in part, by special interests and political ambition. This proposal is further complicated by the unreasonable proposition that the City's form of government be transitioned in a period of less than one year.

**TBC's Suggestion:** Reject this amendment entirely. This is an attempt by special interest groups to more easily influence policy making and access the operational levers of power within the city. Further, the proposal has not sufficiently demonstrated the need for wholesale change in our city's form of government. Should the council choose to put a form of government amendment on the ballot we believe that significant changes to the CRC's proposal are needed. It must be simplified to provide only the basic structure setting up an executive branch. Additionally, to be a productive model, it must provide clear lines of authority and not set up a system in which the mayor is sharing power with the legislative branch (the Council) as the CRC's version attempts to do. Finally, given the city's inherent budget restraints, Council must keep an eye on reducing the proposed executive bureaucracy.

In closing, we understand and appreciate the enormous amount of time and effort spent by the CRC in crafting these proposed amendments as well as the arduous task facing the council in deliberating them. Thank you for considering our concerns.

As a member of the CRC, I endeavored to provide the Council will a throughout review of our municipal charter to find opportunities for charter clarity and to better support our government's operation, as well as support CRC member ideas that deserved the public consideration of Council.
