Exit Interview - State Auditor-

Retirement Director, Catherine Marx introduced Melissa Lee and Suzette Moon of the Office of the Washington State Auditor who presented the Exit Conference for the 2023 Tacoma Employees' Retirement System's financial audit. The Office of the Washington State Auditor's (OWSA) Financial Statements Audit Report, No. 1034116, was distributed to the Board in the Board packet; it will also be available on the OWSA website. It was noted in the Independent Auditor's Report that the Tacoma Employees' Retirement System had received an audit opinion for the calendar year 2023. There were no uncorrected misstatements and no material misstatements in the audited financial statements or schedules. The next annual financial statement audit for TERS is scheduled to begin in April 2025, although an audit of GASB 68 disclosures will occur later in 2024.

Old Business

<u>Investment Update-</u>

Chief Investment Officer, Tim Atwill presented an update on current investment activity. He reviewed low-volatility equity investing and made a recommendation to add a second manager to this allocation.

Motion: Upon motion by Michael Hall and seconded by Gordon Cavanaugh, the Board of Administration authorizes staff to hire BlackRock to manage a passive exposure to the FTW Global Large Minimum Variance Index for TERS.

Retirement Director's Report

Retirement Director, Catherine Marx presented the Retirement Director's Report to the Board. The Retirement Director's report serves as an addendum to the minutes. Additionally, Retirement Director, Catherine Marx verbally informed the Board of an active PDR that may require their response.

Tim's Tenure Presentation-
