Subject: Special Event Permit No. 18-0114 North &th and Cedar Street Block Party

Permission is hereby granted to you for the Block Party event to be held **Sunday, September 23, 2018**; from 5:00 until 11:00 PM. The event will take place on North 7th Street, from North Alder to Junett streets.

Permit Number 18-0114 is issued contingent upon the following conditions:

1. Permit holder shall arrange a meeting immediately with Special Events Sgt. Gary Roberts if there are changes from the approved permit; Sgt. Roberts can be reached at (253) 405-9056. The Tacoma Police Department does not see reason to deny this event from being held; with the following stipulations.
 - a. Permit holder will notify all participants to obey all City of Tacoma; Pierce County Washington State and Federal rules, regulations, and laws.
2. The Traffic Engineering Division has reviewed the Special Event Permit Application and has no objections.
 - a. You agree to provide your own road barricades and any other traffic control devices needed to conduct the safest possible road closure.
 - b. Remember to maintain a 6-foot, unobstructed pedestrian right-of-way and handicapped access through the event area at all times.
 - c. **Access to residents' homes by residents and guests in motor vehicles should be available at all times, with emphasis on pedestrian safety.**
 - d. Tyler Daniels, Traffic Engineering Division, can be reached at (253) 591-5554 if you have questions.
3. The Fire Department has reviewed the application and sees no reason to deny it, with the following conditions:
 - a. Emergency vehicle access will be allowed for the entire extent of the event venue.
 - b. The following things must remain visible, and the path to them must remain unobstructed: Fire hydrants, Sprinkler connections, Standpipe connections, Fire alarm boxes, Building entrances, Exit doors, Aisles, Exit lights, Stairways, Hose cabinets, Fire extinguishers, and any other Emergency equipment.
 - c. Questions about fire regulations can be directed to Lt. Ken Hansen at (253) 591-5762.
4. In regard to noise levels, the event shall comply the following provisions:
 - a. The event shall not make, continue, or cause or permit to be made or continued, any sound attributable to any device that increases the total sound level in excess of 10dBA above the ambient sound level at a neighboring property between 7:00 am to 10:00 pm. All Noise Code requirements shall apply per *TMC* 8.122. If you have any questions, you may contact Craig Kuntz, Planning and Development Services, at (253) 594-7820.
5. That you have this permit letter readily available during the event, and shall present this permit upon demand of any City official.
6. **You insure that neighbors on your street are notified of the street closure for the time permitted, and if requested, you will allow access to homes and driveways.**

Page 2.

Failure to comply with any of these requirements constitutes a violation of the permit as granted and the event may be terminated by the permitting authority or her designee. Noncompliance may also jeopardize the approval of future events. This permit is granted subject to all other applicable laws and ordinances. This permit does not constitute a waiver by the City of any laws or ordinances that may apply to the permitted event or any activities associated with the permitted event.

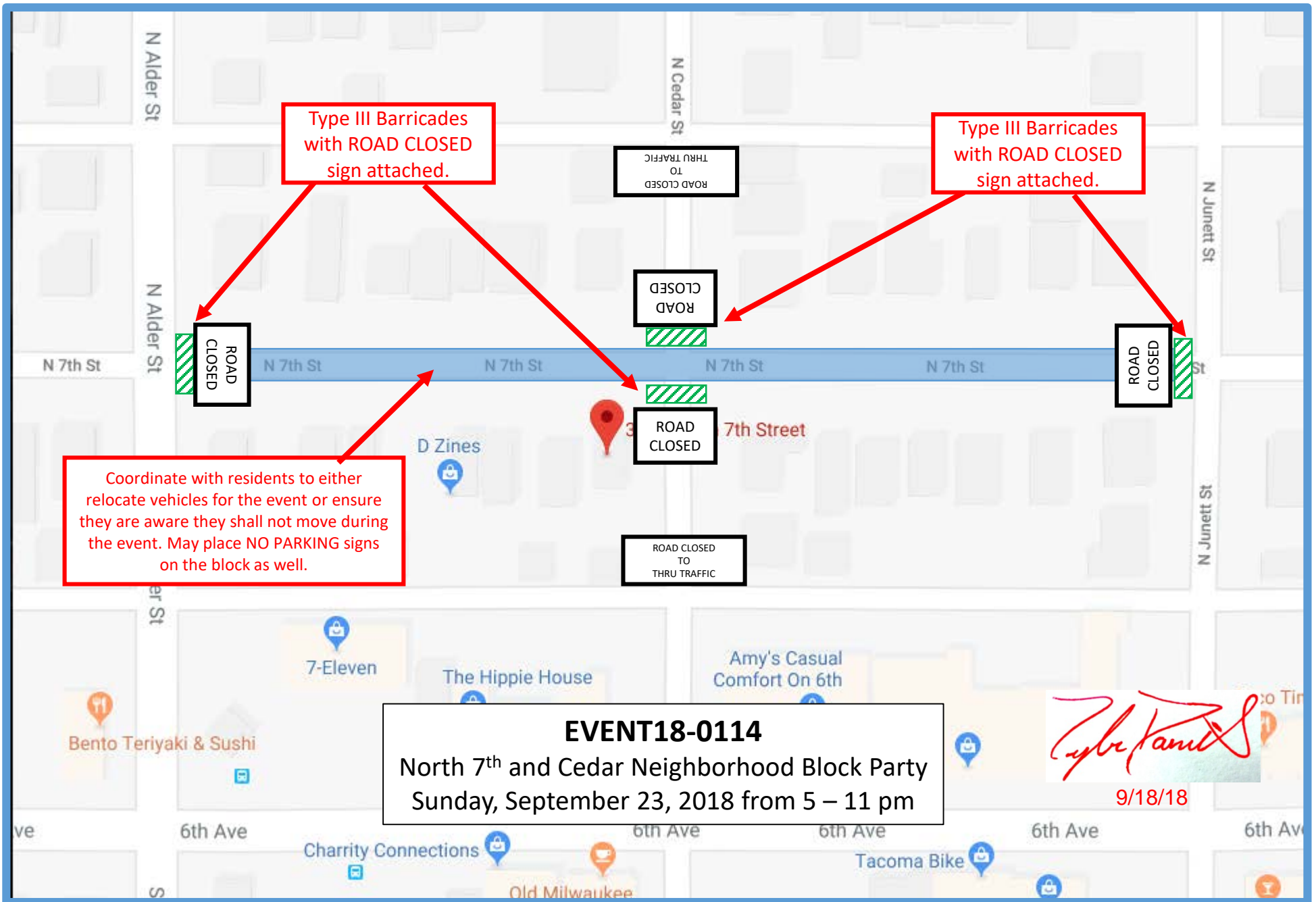
