#### **To local resident or business owner:**

This notice is to inform you of a pending application for a Special Event Permit which will impact roads and/or other public right-of-way in your neighborhood. Closing the road during this event is required for the greatest public safety. Efforts will be made to minimize the impact to your residence or business. Event coordinators are required to instruct participants to follow all applicable City, State and Federal laws. Access to private driveways, parking lots/garages, sidewalks, walkways and/or alley ways may be delayed during the event; emergency vehicles will always have access to roads. This letter has been mailed to the general surrounding area as part of our public notification process. Please feel free to share with others in your neighborhood.

#### **ROAD CLOSURE IMPACTS AND EVENT INFORMATION**

The **Santa Runs Half-Marathon** will take place on Saturday, December 8, 2018 and involves lane closures along A Street, S 11th Street, East E Street, E 7th Street, E 3rd Street, East D Street, St. Paul Ave, E 15th Street, Dock Street, Schuster Parkway, and Ruston Way.

Closures will begin as early as 5:30 AM and will reopen at approximately 11:30 AM. One block of A St. will be closed from S.10th St. to S. 9th St. to stage the start line from 5:30 AM to 9:30 AM. Dock St. South bound will remain open through the event. The Waterside of Schuster Pkwy will be closed from 9:00 AM to 11:30 AM. South bound Ruston Way (hill side lane) from N. 49th St. to McCarver St. will be closed from 9:00 AM to 11:30 AM. Temporary "No Parking" signs will be posted alongside the streets announcing the dates and times that no parking will be enforced.
